CCDT is seeking new trustees who are dynamic individuals with the capacity to contribute, and willing to share their knowledge and expertise. The board of trustees currently draws on a broad spectrum of experience that includes Project Management, Community Partnership, Risk Management, Strategy, Governance, Finance and Fundraising.

Background

Cambusbarron Community Development Trust (CCDT) was established in 2010 with the aim of helping local organisations deliver projects and services to people within the Cambusbarron community.

CCDT's Purpose

- To advance environmental protection or improvement including preservation, sustainable development and conservation of the natural environment, the maintenance, improvement or provision of environmental amenities for the Community and/or the preservation of buildings or sites of architectural, historic or other importance to the Community;
- To provide or assist in providing facilities for recreation and other leisure time activity, which will be available to members of the Community and public at large with the object of improving the conditions of life of the Community;
- To advance the education of the Community about its environment, culture, heritage and/or history;
- To manage community land and facilities for the benefit of the Community and the public in general;
- To advance community development within the Community.

What is involved?

As a trustee, you would be instrumental in planning the strategic future of the charity. You would be responsible for ensuring that CCDT is accountable to its beneficiaries, to the Office of the Scottish Charity Regulator (OSCR) and the public in general.

Prospective trustees will be expected to play a role in the operation of the charity by contributing to training, attending events and speaking to the media, depending on the trustee's particular skills and interests. The board usually meets around 10 times per year. We expect trustees to participate in most meetings either in person or via video conferencing. Potential trustees must be eligible to become charity trustees and live or work in the Forth Valley area.

What we are looking for

We are looking for people from a range of backgrounds, with different experience and skills, who can give commitment and time to help us develop our strategy and financial stability. If you are passionate about making a difference, and have a working knowledge or experience in the following areas, we would like to hear from you:

- **Quality Assurance** – knowledge of quality monitoring and evaluation systems and policy development and implementation.

- **Legal** – qualification or experience dealing with legal matters.

- **Social Enterprise** – experience of setting up or working within a social enterprise and understanding legal structures.

- **Media & Marketing** – experience working within the field of marketing, or with the media to influence and raise awareness.

- **Local Authority or Statutory Commissioning**

- **Community Empowerment** – knowledge of community asset transfer, participatory budgeting, participation requests, community planning.
