STRUCTURE GOVERNANCE AND MANAGEMENT

Governing Document

The charity is a Scottish Charitable Incorporated Organisations (SCIO) governed by its constitution effective from 9th March 2017. It successfully converted from a company limited by guarantee on 19th May 2017.

Appointment of Trustees

The Board of Trustees consists of a minimum of three and a maximum of twelve members elected by the Members of the charity at the AGM. No more than four of these trustees can be co-opted non-members

appointed by the board at any time. The Trustees may appoint any other member to be a charity trustee at any time.

Induction and training of trustees

The trustees when elected are provided with a copy of the constitution and other relevant documents and provided with training on their roles and responsibilities of being a trustee of the charity. The trustees are also encouraged to take other training opportunities to enforce their understanding of what is required of them within this role.

Organisational Structure

The Board, which is responsible for the day-to-day management of the charity, normally meets around 12 times per year.

Risk Assessment

The trustees regularly review the risks to which the charity is exposed but consider that CCDT has policies and procedures in place that mitigate any risk. They do not consider that there are any substantial risks beyond the liabilities disclosed in the financial statements. The charity holds employers, public liability and professional indemnity insurance policies which are reviewed on an annual basis.

OBJECTS & ACTIVITIES

The objects of the charity are:

- To advance environmental protection or improvement including preservation, sustainable
 development and conservation of the natural environment, the maintenance, improvement or
 provision of environmental amenities for the Community and/or the preservation of buildings or sites
 of architectural, historic or other importance to the Community;
- To provide or assist in providing facilities for recreation and other leisure time activity, which will be
 available to members of the Community and public at large with the object of improving the conditions
 of life of the Community;
- To advance the education of the Community about its environment, culture, heritage and/or history;
- To manage community land and facilities for the benefit of the Community and the public in general;
- To advance community development within the Community.

ACHIEVEMENTS & PERFORMANCE

As our woodland continued to recover from the felling imposed on us by the Statutory Plant Health Notice (SPHN) we progressed a number of projects to improve and develop our woodland:

- Residential boundary area felling completed
- Lily pond and castle pond areas cleared of invasive species and opened up for access,
- Invasive specific identification and control plans being developed,
- Polmaise Castle & Gardens maintenance and continuing to uncover its history,
- Continued clearance and development of the walled garden. We have begun our first harvest of produce contributing to the community larder (produce available at the Community Centre),
- Firewood processing and sale to local residents,
- Memorial benches manufacture and installation,
- Tree safety work,
- New signs, accessible path route and drainage improvements.
- Educational events for groups and families

The tree planting has taken place at the residential boundary area. This is the first significant planting that has happened in Gillies Hill in over 50 years with over 300 trees planted by a team of volunteers, same as young as 3 years old.

Outside the woodland we have continued to maintain the public access defibrillator at the community centre.

FINANCIAL REVIEW

Overview

The silver lining of losing some of the trees is that through the compensation we now have an increase in unrestricted funds which allows the trustees to be able to budget in a more sustainable way and to further develop and undertake the work of the charity.

Fund Raising

The charity signed up for the Stirling Community Lottery and within this year received unrestricted income of £587 (2022: £48) and this continues to be a regular source of income.

Donated Facilities & Services

CCDT thanks go to all of the trustees and volunteers for their time and efforts without which the charity could not undertake its activities.

Investment Policy

The Trustees are aware of their responsibilities for safeguarding the charity's assets. They regularly consider the political, economic, legal and environmental factors than can affect funds and savings. The Trustees have a duty to seek out suitable sources of income generation. The Trustees also consider that it is prudent to accumulate funds for reserves to meet their legal requirements for employees and creditors. They also realise that this has to be balanced by ensuring that there are enough funds readily available to carry out the charity's aims. The Trustees have the power to invest funds in the best interest of the charity. To meet these ends the Trustees have invested in land known locally as Gillies Hill. The Trustees believe that the current investment has a suitable risk and reward profile that meets the investment criteria and risk appetite of the charity.

Reserves Policy

In line with their governance and financial strategy the trustees are agreed that reserves are essentially the funds that a charity may set aside to ensure is financial stability, to cover unexpected expenses and for the charity to achieve is objectives over the long term. Due to the present financial climate and the competitive nature of attracting funding The trustees have set a target of a between nine to twelve months running costs to be set aside as reserves, using this year's essential expenditure as a benchmark this amounts to £5,000. At the end of this financial year the reserves are £55,515 (2022: £Nil) and the extra funds will be used to continue the work of the charity.

FUTURE PLANS

The trustees are presently revisiting their business plan and have a number of ideas that they wish to be able to take forward including continuing the work on the replanting and managing of the woodland

INDEPENDENT EXAMINER'S REPORT

Independent Examiner's Report to the Trustees of Cambusbarron Community Development Trust

I report on the accounts of the charity for the year ended 31 March 2023, which are set out on pages 7 to 12.

Respective responsibilities of Trustees and Examiner

The charity's trustees are responsible for the preparation of the accounts in accordance with the terms of the Charities and Trustee Investment (Scotland) Act 2005 ("the 2005 Act") and the Charities Accounts (Scotland) Regulations 2006 (as amended) ("the 2006 Regulations"). 1. Basis of Preparation

These accounts have been prepared on the receipts & payments basis in accordance with:

- (a) The Charities and Trustee Investment (Scotland) Act 2005
- (b) The Charities Accounts (Scotland) Regulations 2006 (as amended)

2. Fund Accounting

- (b) Designated funds are unrestricted funds that the trustees have set aside for particular purposes. The designation is administrative only and does not restrict the trustees' ability to apply the funds.
- (c) Restricted funds are those that may only be used for specific purposes. Restrictions arise when specified by the donor, or when funds are raised for specific purposes.
- (d) The purposes of the funds are shown in Note 9.

3. Taxation

- (a) The charity is not liable to corporation tax or capital gains tax on its charitable activities.
- (b) The charity is not registered for VAT, thus all costs are shown inclusive of VAT charged.
